4.	Age limit	Not exceeding 56 years on the closing date of receipt of application i.e. 30.06.2026 Upper age limit is relaxable upto 05 years in case of SC,ST or as specified for any category by Government of India from time to time.

Educational and other qualifications	<b>Educational Qualifications</b> : Bachelor of Commerce degree/BBA from a recognized University securing not less than 50% marks in aggregate. <b>Experience</b> : At least 08 years of service in administration and accounts and Office Documentation in any Central/State Government Institute of Hotel Management or Food Craft Institute or Public Sector Undertaking or Autonomous Body in the Grade Pay of Rs.4200/- or equivalent/above. Computer competency is essential.

1. The prescribed Application format along with detailed notification is given on the Institute website : [www.ihmbbs.org](http://www.ihmbbs.org) and interested/eligible candidates must apply in the prescribed format only attaching therewith recent passport size photograph along with self-attested copies of all the relevant documents in support of date of birth, qualification, experience etc.
2. Only such candidates should apply who are willing to come on Deputation and while forwarding by the employer, a No Objection Certificate should be provided during the time of interview issued by the employer, failing which such candidate will not be allowed for interview. The application should be accompanied by attested copies of ACRs/APARs for the last 05 years along with Vigilance Certificate.

4. The required qualifications, relevant experience, and other eligibility conditions, if any, shall be determined as on 30.06.2026 in accordance with the applicable DoPT guidelines and the Recruitment & Promotion Rules of the Institute.
5. **Applications along with all the required enclosures must reach this Institute by 30.06.2026 by 5.00 p.m. through post only.** The application forms without enclosures of self-attested supported documents/testimonials shall be treated as invalid. Incomplete and applications received after 30.06.2026, 5.00 p.m. will be rejected. The Institute will not be responsible for any postal delays.
6. Candidates who fulfill the criteria for the above mentioned post shall be called for Interview. Candidates will have to produce Original Proof of the details furnished in their application at the time of interview. The terms and conditions of appointment on deputation shall be regulated in terms of Department of Personnel & Training's Office Memorandum dated 05.01.1994 as amended from time to time and Recruitment & Promotion rules of the Institute.
7. In exceptional cases where the deputationist is not found fit to discharge his /her duties and responsibilities to the satisfaction of the competent authority, such deputations could be reverted back to his parent office even before the expiry of the period of deputation.
8. No TA/DA will be paid to the candidates who will be called for interview.
9. The competent authority reserves the right to fill or not to fill vacancy or to re-advertise the post without assigning any reason.
